Ph.D in any branch of Science/Computer Science with 4 years experience in System/ Networking Administration.

**Desirable:** Candidates having a proven background in concepts and applications of organising information/ data retrieval from online systems, database administration, Local Area Network (LAN), Server maintenance and troubleshooting for LAN/WAN and networking issues would be given preference, Structural Biology, Modelling, Software development, analysis, experience in Lab, website management and development, exposure to Bio informatics application.

**Age Limit**: 40 years as on last date of the application.

#### **General Conditions**:-

- 1. The appointments will be made initially on contract for a period of 5 years with a probation period of 1 year, which may be extended. The performance will be reviewed on completion of 4 years and further continuation of appointment will depend on the performance during this period.
- 2. Canvassing in any form will be a disqualification.
- 3.
