

1. ESSENTIAL EDUCATIONAL QUALIFICATIONS AND EXPERIENCE ETC

Sr. No.	Name of the Post	Essential qualifications & experience required for the post
1.	<u>Clinical Psychologist</u>	M.A in Clinical Psychology with 2 years teaching/research experience from a recognized institute.
2.	<u>Social Worker</u>	Master's in Social Work. Desirable: Two years of experience in the field of Disabilities

2. TENURE OF THE POST

The above said posts are purely temporary in nature and will be filled up on contract basis initially for a period of one year or till the regular arrangements are made, whichever is earlier. It is also made clear that it is an engagement for a fixed term and shall automatically cease on the expiry of the contract/term without providing any claim to a person so engaged to any regularization of service or any consequential benefits.

3. UPPER AGE LIMIT AS ON 01.01.2015:

The upper age limit for the above said posts are as under: -

4. RESERVATION AND RELAXATION:

- (a) The reservation and relaxation in the upper age limit will be made only for the category of the post reserved for such categories, as per the instructions issued by the Government of India from time to time.
- (b) The SC/OBC candidates applying for un-reserved posts are not entitled to any relaxation in upper age limit.


7. OTHER TERMS AND CONDITIONS:

- (i) The number of post(s) are tentative and liable to increase or decrease for different category, as per requirement.
- (ii) The applications should be submitted in a prescribed proforma and the discipline/subject for which the application is being submitted needs to be indicated clearly. The applications that are not submitted in the prescribed format will not be considered.
- (iii) Incomplete/unsigned applications and application received without fee, photograph, self attested copies of required certificates such as

educational qualifications, experience, age, caste/community certificate etc. and those received after the prescribed last date of receipt of applications will be summarily rejected without any communication to the candidate.

- (iv) The applications received by post directly beyond the last date of receipt of applications will not be entertained under any circumstances. This institute will not be responsible for delay/late delivery by the postal department.
- (v) The candidates will be called for interview based on their eligibility. However, the decision of the competent authority as to their eligibility or otherwise of a candidature for interview or selection will be the final and no correspondence/ personal enquiries will be entertained.
