(03 years) and Physically handicapped (10 years). 1. Before applying to the post of Peon, the candidates should ensure that he/she fulfills eligibility criteria. This office shall reject the applications not fulfilling the requisite criteria at any stage of recruitment and if erroneously appointed such candidate shall be removed from the service.
2. List of eligible/ineligible candidates, date of interview/suitability test, list of successful candidates and further updates will be displayed on the site **ecourts.gov.in/chandigarh** from time to time and no letter in this regard will be issued separately by this office.
3. The applications must be submitted on the prescribed proforma only, which can be obtained by hand from the office of the undersigned on any working day between 11:00 a.m. to 01:00 p.m. and 2:00 p.m. to 04:00 p.m. from **28.08.2017 to 06.09.2017**.
4. Self attested copies of relevant testimonials i.e. proof of qualification, Date of birth, Category belongs to, two recent passport size photographs duly attested by Gazetted officer, etc. must be attached with the application form. Applications without copies of relevant testimonials and that received after **06.09.2017** (even by Post) will not be entertained. Incomplete applications and applications not on prescribed proforma will be summarily rejected.
5. Number of posts (mentioned above) may increase or decrease.
6. The post of reserved category except the post reserved for physically handicapped will be offered to the candidate of General Category, if no suitable candidate from the reserved category is found available.
