Horizontal Reservation has been given to PWD/Ex-Serviceman Category (disabled or otherwise) and dependent of personnel killed in action. Ex-Servicemen who have already secured employment in civil side under Central Government in Group 'C' & 'D' posts on regular basis after availing of the benefits of reservation given to Ex-Servicemen for their re-employment are NOT eligible for fee concession or for claiming benefits of reservation under EX-Servicemen category. \* Candidates who have completed and possess the Qualification as on or before **01.08.2017** are only eligible to apply. Candidates who are appearing at the qualifying exam or their proof of passing/result is not declared in public domain through newspapers/websites etc. by **01.08.2017** are **NOT ELIGIBLE** for applying these posts.

### NOTE -

- i. CANDIDATES ARE REQUIRED TO SUBMIT THE ONLINE APPLICATION FORM ONLY ONCE. In case of multiple applications are received from single candidate, the candidature shall be summarily rejected.
- ii. No printed / hard copy of the filled Application Form or any other supporting documents is to be sent before short-listing based on Written Test and/or Physical Endurance Test unless asked to submit specifically.

### **RESERVATION AND RELAXATIONS:**

- 1. The prescribed qualifications, experience, age limit, etc. shall be reckoned as on <u>01.08.2017</u>. The maximum age limit can be relaxed by 5 years in case of SC/ST candidates and 3 years for OBC candidates.
- 2. There will not be any upper age limit in case of departmental (FCI) employee.
- 3. The upper age limit is relaxed by 10 years for PWD / PH candidates, 15 years for PWD / PH candidates belonging to SC/ST and 13 years for PWD / PH candidates belonging to OBC.
- The aforesaid reservation and relaxation is not applicable to OBC candidates falling within the Creamy Layer. That shall be applicable to Non-Creamy Layer (NCL) OBC candidates only.
- 5. Age is additionally relaxable by 5 years for those applicants who had ordinarily been domiciled in the Kashmir Division in the State of Jammu and Kashmir during the period 01-01-1980 to 31-12-1989. Any applicant intending to avail the relaxation under this category shall have to submit a certificate from the District Magistrate in Kashmir Division under whose jurisdiction she/he had ordinarily resided or any other authority designated in this behalf by the Govt. of Jammu & Kashmir to the effect that she/he had ordinarily been domiciled in the Kashmir Division of the State of Jammu & Kashmir during the period from 01-01-1980 to 31-12-1989.
- 6. For Ex- Serviceman the Upper Age limit shall be relaxed as on **01.08.2017** by allowing the deduction of length of actual Military/Defence Service from his actual age and the resultant age shall not exceed the

maximum age limit prescribed for the Post by more than 3 years (8 years in case of SC/ST; 6 years in case of OBC Candidates).

- 7. Erstwhile Contractual Security Guards who have worked atleast for a period of six months with FCI prior to 22.08.2002 i.e. date of order of Hon'ble Punjab & Haryana High Court in CWP No. 4695 of 1999, will be given relaxation in age as well as qualification & also in qualifying marks in wr tten test as directed by the Hon'ble High Court. However such candidate is required to upload Affidavit in prescribed format given at <u>Annexure-F</u> while submitting online application. Further such candidates will be required to produce original I-Card and salary slip pertaining to the period they w∋re engaged as contractual security guards.
- 8. Casual Workers working in FCI as on 31.12.2012 will also be given relaxation in age and qualification at par with erstwhile contractual security guards, in light of FCI, HQrs Circular No.OMISS-03-2C13-03 dated 16/17.03.2013.
- 9. The applicants for Compassionate appointment, whose applications are pending in the roster of appointment on compassionate grounds for any post in Cat-III and IV posts as on 31.12.2012, the same may also apply, if willing to work as "Watchman".

### <u>NOTE</u>

- i. Ex-Servicemen who have already secured employment in civil side under Central Government in Group 'C' & 'D' posts on regular basis after availing of the benefits of reservation given to Ex-Servicemen for their re-employment are NOT eligible for fee concession or for claiming benefits of reservation under EXS Category. However, they are eligible for age relaxation only.
- ii. The period of "Call up Service" of an Ex-Serviceman in the Armed Forces shall also be treated as service rendered in the Armed Forces for purpose of age relaxation.
- iii. For any servicemen of the three Armed Forces of the Union to be treated as Ex-Serviceman for the purpose of securing the benefits of reservation, he must have already acquired, at the relevant time of submitting his application for the Post/Service, the status of Ex-Serviceman and/or is in a position to establish his acquired entitlement by documentary evidence from the Competent Authority that he would complete specified term of engagement for the Armed Forces within the stipulated period of one year from the closing date.
- iv. An Ex-Serviceman or Physically Handicapped (OH) category candidate who qualifies on the basis of relaxed standards viz. age limit or qualifications, in written examinations, etc. is to be courted against reserved vacancies and not against General vacancies subject to fitness of such candidate for selection. In so far as cases of Ex-Servicemen are concerned, deduction from the age of Ex-Servicemen is permissible against the reserved or unreserved posts and such exemption cannot be termed as relaxed standards in regard to age.

### **EXPLANATION I**:

An Ex-Serviceman means a person who has served in any rank whether as a combatant or non- combatant in the Regular Army, Navy, Air Force of the Indian Union, and who retired from such service after earning his/her pension. This would also include persons who are retired/retire at their own request but after having earned their pension; or

- a. who has been released from such service on medical grounds attributable o military service/circumstances beyond his control and awarded medical or other disability pension; or
- b. who has been released, otherwise than on his own request from such service as a result of reduction in establishment; or
- c. who has been released from such service after completing the specific period of engagement, otherwise than at his own request or by way of dismissal or discharge on account of misconduct or inefficiency, and has been given a gratuity; and includes personnel of the Territorial Army of the following categories,

namely:-

- i. Pension holders for continuous embodied service,
- ii. Persons with disability attributable to military service; and
- iii. Gallantry award winners.

### **EXPLANATION II:**

The persons serving in the Armed Forces of the Union, who on retirement from service, would come under the category of "Ex-Serviceman" may be permitted to apply for re-employment one year before the completion of the specified terms of engagement and avail themselves of all concessions available to Ex-Servicemen but shall not be permitted to leave the uniform until they complete the specified term of engagement in the Armed Forces of the Union.

- v. Age concession is not admissible to Sons, Daughters and Dependents of ex-serviceman.
- 8. Age Relaxation is applicable to Widows/Divorced Women/Women judicially separated and who are not remarried up to 35 years, 38 Years and 40 years for Unreserved, OBC and SC/ST respectively.
- 9. ELIGIBILITY CRITERIA FOR ERSTWHILE CONTRACTUAL SECURITY GUARDS:-
- i. Maximum age for General Category erstwhile Contractual Security Guards shall be 54 years as on <u>31.03.2018\*</u> i.e. the probable date of completion of entire recruitment process so that the candidates belonging to reserve category may be confirmed to the post after service of one year, which is prerequisite for confirmation to the post as per FCI rules.
- ii. In view of relaxation in age given above, the candidate who does not work for atleast 5 years after final selection to the post of Watchman in FCI will not be eligible for Gratuity as per Payment of Gratuity Act.
- iii. Relaxation in age will be available as per GOI Rules to reserved category Erstwhile Contractual Security Guards <u>but these Contractual Security Guards belonging to "ST Category" will not be eligible for</u> <u>purpose of Reservation since FCI, RO, Punjab is following reservation applicable to Punjab State</u> <u>Government only as per FCI Hgrs., New Delhi Circular No.EP-21-2007-03 dated 09.03.2007. However,</u> <u>(ST'candidates can apply under 'UR' category.</u>
- iv. The minimum qualification is 5<sup>th</sup> pass for erstwhile contractual security guards.
- v. The erstwhile contractual security guards to produce I. Card or Salary Slip as a proof of having worked with FCI as contractual security guards. Besides they shall have to submit Affidavit as suggested by the Joint Committee of FCI Punjab & Haryana Regions.
- vi. The relaxation in Punjab Region will be given only to the workers who had worked as contractual security guards in Punjab Region of FCI.
- vii. As per Hon'ble High Court of Punjab & Haryana order dated 22.08.2002 in CWP No 4695 of 1999 the erstwhile contractual security guards will be entitled to relief in the light of observation made in Hon'ble Supreme Court in case of Steel Authority of India (SAIL) therefore any contractual security guard engaged after 22.08.2002 will not be considered eligible for relaxation.

\*The Cut-off date is to allow these Erstwhile Contractual Security Guards to work for a minimum of 1 year so as to be eligible for confirmation to the post after successful completion of probation, in respect of 'SC/ST' candidates. This is in consequence with the Hon'ble Punjab & Haryana High Court order dated 22.08.2002 in CWP No. 4695 of 1999.

- 1. FCI reserves the right to introduce additional phase of written examination / screening Test in compelling circumstances for screened candidates on the basis of performance in written test and decision regarding calling such number of candidates shall be decided by FCI only.
- 2. The number of candidates will be shortlisted for PET in the ratio of 1:3 and will be informec about the venue of PET through website **www.fcipunjabapply.com**. The candidates are advised to keep visiting the websiteregularly.
- 3. The PET is of qualifying nature only.

### **GENERAL INFORMATION / INSTRUCTIONS:**

- 1. Nationality: A candidate for appointment in the service of the Corporation shall be :
- i. a Citizen of India, or
- ii. a subject of Nepal, or
- iii. a subject of Bhutan, or
- iv. a Tibetan refugee who came over to India before the 1<sup>St</sup> January, 1962 with the intention of permanently settling in India, or

- 15. No change in centre of examination will be allowed under any circumstances. Hence, the candidates should select the centre carefully and indicate the same correctly in their applications.
- 16. The Corporation reserves the right to cancel or add any additional centre and ask the candidates of that particular Centre to appear from any other Centre. Corporation also reserves the right to divert candidates of a particular Centre to some other Centre to take the written examination.
