AGE CRITERIA

Age:- Candidate should not be below 18 years and above 47 years (10 years age relaxation included) of age as on the first day of January, 2019.

4. Important instructions/information

- (i) Application proforms for the above different kinds of posts of Service Group-C and D are annexed as per Annexure-1 to Annexure-6.
- (ii) Application sent through registered posts or by hand will only be entertained in the office of Director, Local Government, Punjab (Recruitment Cell), Room No. 308, Punjab Municipal Bhawan, Plot No. 3, Sector-35 A, Chandigarh.
- (iii) Last date of receipt of application is 20.06.2019. Applications received after the due date will not be entertained.
- (iv) Candidate is required to paste one self-attested photograph on the application form and to attach the second with the application form separately.
- (v) Number of posts advertised for different category of posts may vary.

- (vi) Reservation will be as per policy of the State Government. The benefit of reservation shall only be available to the candidates who are bonafide residents of Punjab State.
- (vii) The candidates shall clearly indicate, in the prescribed form, the category of reservation under which he/she wants to be considered. The category of reservation once opted will not be allowed to be changed.
- (viii) Government/Semi Government employees are required to bring "No Objection Certificate" from their employer at the time of verification of certificates/documents.
- (ix)(a) The appointee will be paid emoluments as per Punjab Government policy prescribed from time to time.
 - (b) The appointee shall be governed by New Defined Contributory Pension Scheme.
- (x) No fees will be charged from the candidates.
- (xi) No TA/DA will be given to the candidates.

5. Procedure of selection

- (1) There shall be no written test or interview marks.
- (2) For Clerks
 - (i) Should qualify English and Punjabi typewriting test, respectively, on a computer at a speed of 30 words per minute.
 - (ii) Exemption from proficiency in type writing shall be granted on the basis of certificate issued by the competent authority.
 - (iii) All candidates shall be called for Punjabi and English typewriting test on computer.
 - (iv) The list of eligible candidate category wise, would be put up on the Department websites.
 - (v) The selection of eligible candidates will be on the basis of Graduation only. The merit list of eligible candidates will be prepared on the basis of %age of marks obtained in Graduation.
- (3) For rest of the posts, the selection will be made as per merit prepared on the basis of essential qualifications subject to fulfilling of the eligibility criteria and suitability for the job.
- (4) Different categories of posts in Service Group-'C' and 'D' shall be filled up by organizing "Special Recruitment Camp at the State Level". The date of aforesaid Camp will be intimated lateron.
- (5) The candidates will be requested to bring the following original certificate/ documents alongwith one spare set of self attested copies of documents in the Special Recruitment Camp:-
 - (1) Educational Qualification (2) Disability Certificate
 - (3) Photo Identity (4) Proof of Age
- (6) In the case of two or more candidates obtaining equal marks, the candidate older in age shall be placed higher in the order of merit.
- (7) Eligibility of candidates for concerned post will be determined by the Screening Committee. The selected candidates will be allocated for appointment to the concerned Municipal Corporations and Municipal Councils-Nagar Panchayats by the Screening Committee and its decision in this regard shall be final
